Provincial Attestation Letter (PAL)

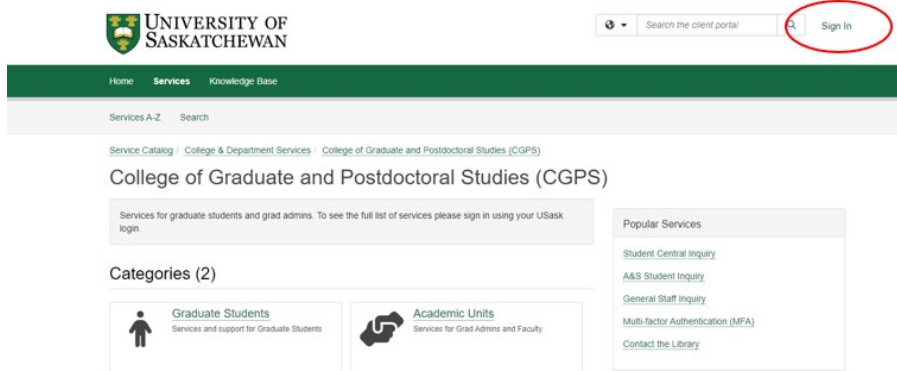
On September 18, 2024, Immigration, Refugees and Citizenship Canada (IRCC) announced an important update regarding the Provincial Attestation Letter (PAL) requirement for master's and PhD students. Since early 2024, PALS have been required for undergraduate students, graduate certificate students, and VRS students (enrolled for six months or more). Now, this requirement is being extended to master's and PhD students.

However, the new PAL requirement isn't in effect just yet. If a graduate student has a Letter of Acceptance (LOA), we recommend applying for their study permit as soon as possible, as they currently don't need a PAL.

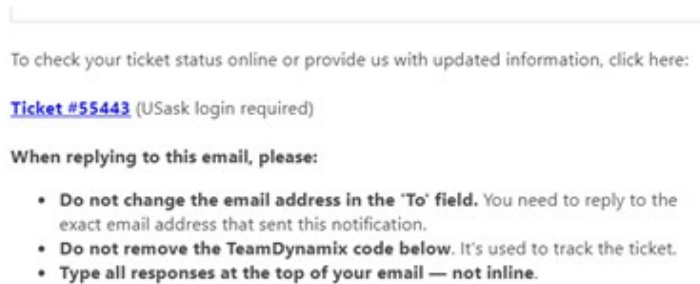
TDX Updates

As we all get more comfortable with TDX, you may find the following tips helpful:

TDX Login Reminder: To access all services and forms, users are required to [sign-in](#). If a user is not logged in, only public forms will be visible.



Email Responses: Please remember to type your response at the top of the email and keep all email details intact. This will ensure your reply is correctly linked to the right ticket. You'll see a reminder of this is in TDX emails, as shown below.



Attachment Size Restriction: There are limits on the size of files that can be attached to a ticket on creation.

- Ticket Requests
 - Limit is 20MB; this is the limit for the drag and drop feature for content being uploaded at once
 - To attach multiple files, you must select Browse and the files must all be in the same folder
 - From the Client Portal > Ticket Requests > Select the ticket > Add Attachment from top menu; limit is 54MB
- Attaching External Files - TDX supports the following file hosting services
 - Box
 - Dropbox
 - Google Drive
 - OneDrive (Personal)
 - OneDrive for Business (as of version 9.4+)
